# MINUTES REGULAR MEETING December 10, 2024

Council for the City of Covington held a regular meeting on Tuesday, December 10, 2024 at 6:30 p.m. in the Council Chambers of City Hall located at 333 W. Locust Street, Covington, Virginia. Preceded by a reception for outgoing Mayor, Mayor Thomas H. Sibold, Jr. and Vice Mayor David S. Crosier.

Mayor Thomas H. Sibold, Jr. called the meeting to order with the following members present: Mayor Sibold; Vice Mayor David S. Crosier; Councilman William (Lance) Carson, Jr.; Councilman Fred F. Forbes; Councilman Raymond C. Hunter. Also present were City Manager Allen Dressler and City Attorney Mark Popovich.

The invocation was given by Pastor Steve Noel followed by the Pledge of Allegiance.

#### Approval of Agenda

Mr. Crosier motioned to approve the agenda with the exception to add Resolution R-24-37, "Respect in Memory of James Robert "Cheeze" Smith", seconded by Mr. Hunter. All members were in favor with "aye" votes.

There were no citizen comments.

# **Public Hearing**

Mayor Sibold opened the Public Hearing to amend and reenact Section 10-262, Alcoholic Beverages and Beer, by revising the license tax for certain types of alcohol in conformity with state law. There were no comments for or against this amendment. The public hearing was closed.

He also thanked staff at the Water Treatment Plant for all their work; he thanked Police Chief Smith and his department; he thanked Mayor Sibold and Vice Mayor Crosier for their work for 12 years on City Council and all their accomplishments. Mr. Dressler wished everyone a Merry Christmas and a Happy and Healthy New Year.

## Appointment

1) The term for the League of Older Americans (LOA) Advisory Council is expiring on December 31, 2024. Mr. Hunter is on the board and does not desire to be reappointed. This can be a citizen or council appointment. There are approximately 5 meetings per year. This is a 2-year term. Council will be looking for someone interested in being appointed to this Advisory Board.

# Ordinances and Resolutions

There was discussion that R-24-35 for Opioid Settlement Recoveries can be used for different things. David Bryant, Finance Director, stated that he would review how it can be used. There is \$80,000 in an account that has been collected and no funds have been spent.
